


participated in many slets. We have special memories of her as she gymed with us as far back as Mary Kadrik's teaching years.

WHO WAS MILAN GETTING?

Today's younger Sokol USA members recognize the name of Milan Getting from Sokol USA's scholarship program. However, many are not familiar with Getting's great accomplishments.

From a historical perspective, Milan Getting was an amazing man who did many great things. He emigrated from Slovakia to Pittsburgh in 1902. He was an avid Sokol. He was devoted to the Sokol values of freedom, brotherhood and equality.

The *Slovensky Sokol*, a bi-monthly newspaper, came into existence in June 1905. The *Slovensky Sokol* was the official newspaper of the Slovak Gymnastic Union Sokol of the U.S.A., now called SOKOL USA. In the initial formative years (1905-1908) of the newspaper, Karol Stiasny and Milan Getting served as editor and it appears as alternating years. Milan Getting recognized the value of having a publication which would keep the Sokol Lodges informed and in contact. Getting was firmly the paper's editor from January 1908 through mid-1919.

Getting was also a leading proponent of independence for the Slovaks and Czechs from the Austro-Hungarian Empire. He wrote unceasingly in support of his vision of a Slovakia free from the bonds of the Habsburg Empire. He published many articles in the campaign for independence from Austria-Hungary.

He promoted the concept of an alliance of Czechs and Slovaks in a state of their own outside of the rule of Austria-Hungary.

When World War I broke out, Getting tirelessly organized events promoting men to volunteer to enlist in the Czechoslovak legions fighting on the Western front and he worked to raise money for the war effort. As the end of the First World War neared in 1918, Getting worked unceasingly to raise the public's consciousness for Czech and Slovak independence from Austria-Hungary.

In May 1918, Getting was a key participant in the Pittsburgh meeting of American Slovak and Czech leaders with Thomas Masaryk. This meeting resulted in the Pittsburgh Agreement, a document instrumental in the birth of the new country of Czechoslovakia following the end of World War I.

At the end of World War I, Getting returned to Europe and worked in Bratislava for the newly independent Czechoslovak state. Later, he returned to the United States where he served from 1924 to 1932 as the Czechoslovak Consul for Western Pennsylvania and as chief of the Press Bureau at the Czechoslovak Embassy in Washington, DC.

Getting was a multi-faceted and talented man. He helped in creating the Czechoslovak Classroom at the University of Pittsburgh. He also was a talented puppeteer and gave puppet shows for his family as well as for the public at the Jan Hus Church in New York City and in Pittsburgh. Portions of Getting's puppet theater are on display at the Senator John Heinz Pittsburgh Regional History Center in Pittsburgh.

The Milan Getting Scholarship program was established in his honor by Sokol USA. Getting was the voice of the Slovak Sokol and tireless promoter of Sokol's key tenets of brotherhood, equality and independence. It is only fitting that this year's convention banquet will include a silent auction to raise additional funds for the Milan Getting Scholarship program. Getting's tireless work touched many lives and his memorial scholarship continues to do the same.

WPSCA ANNOUNCES ANNUAL SPRING MEETING

The Western Pennsylvania Slovak Cultural Association will hold its 9th Annual Spring Meeting on Sunday, June 14th at 2 p.m. at the Czechoslovak Nationality Room in the University of Pittsburgh Cathedral of Learning. This year's speaker is Karen Melis, who will discuss the basics of DNA testing as it applies to genealogy. She will discuss what DNA testing is and isn't, the testing methods, process and Interpretation of results as well as answer questions or concerns. She will also speak about the advantages of a geographic DNA project and some interesting findings about the Zamagurie Region DNA Project. A lucky volunteer from the audience will be selected to demonstrate how a DNA kit is administered and the results will be provided in six to eight weeks free of charge.

In 1998, Karen began a journey to learn about her Slovak ancestry from the Zamagurie Region. What started as a desire to know who her ancestors were and where they came from grew into more than an interest, but a passion. For over 10 years, she has documented her direct and collateral lines, building on the family relationships through a set of villages. The results went well beyond the genealogy and researching of her family tree. By observation, she could not only identify who was related to whom, but also noted patterns of births and marriages, the effects of catastrophes and plagues in the villages, how marriage partners came from "just over the mountain," and how some surnames migrated or stayed for generations in the Zamagurie Region. Further, she could trace emigration patterns from these villages to Passaic, Chicago and especially Pittsburgh, where her own ancestors migrated.

Mrs. Milas earned degrees in Chemical Engineering and Biology from the University of Pittsburgh. She was also a post-baccalaureate student in the Russian and East European Studies Certificate program. After being awarded the Thomas Kukucka Memorial Scholarship, she continued her Slovak studies at the Studia Academica Slovaca (SAS). Presently, she lives in Butler, Pa., with her husband, Terry. They have two children who are also studying for advanced degrees.

The meeting is open to the public. Admission is free. Following the business meeting, there will be a social hour with snacks and drinks in Room 1228.

Children's Ages & Stages: Part 2 What can they understand? What can they do?

Part 1 of this article covered milestones and appropriate activities for 2 and 3 year olds and was published in the April edition of The Sokol Times. It originally appeared in Technique magazine.

No matter what the activity, children want to have fun. This is especially true for gymnastics classes. If a teacher understands child development and incorporates age-appropriate activities in class, that can go a long way in helping the "Fun Factor!" When you understand the interests and abilities of children at various ages, you can create stations and appropriate challenges to allow them to be successful and have fun.

Listed below are developmental milestones and activity suggestions for 4 and 5 year olds.

Age 4

Physical Development Milestones

Skips on one foot, draws "Man," cuts with scissors (not well), can wash and dry face, dresses self except cannot tie laces, can do standing broad jump, throws ball overhand, high motor drive.

Age appropriate activities to include in your gymnastics class:

Hopping on one foot, then the other.

Skipping on one side, them both.

Hurdle step. Hopscotch one

foot, two feet, etc.

Toss and catch a bean bag.

Toss, clap and catch.

Basic rolls forward and backward with a spot.

Inverted readiness activities to create upper body strength

to create upper body strength.

Balance on different body

Emotional Development Milestones

Seems sure of himself, out-ofbounds behavior, often negative, may be defiant, and seems to be testing himself, needs controlled freedom.

Age appropriate activities to include in your gymnastics class:

Sometimes have negative thoughts like "I can't." When children make those statements, help them to reword the statement to say, "I'll try, but I may need help."

They will usually want to help and be the leader, find ways to make everyone feel special during class. Once they know that everyone will get a turn being first, they will relax and take whatever turn they get.

They enjoy role playing. Make stations where they are different animals or creatures.

Social Development Milestones

Cooperative play, enjoys the company of other children, highly social, may play loosely organized group games such as tag or duck-duck-goose, talkative, versatile.

Age appropriate activities to include in your gymnastics class:

Cooperative games are great, partner games work well.

Class relays (where everyone ends up the winner).

They like to help pick up. Use the clean up game to re-arrange the equipment before you move to another place.

They like to use humor and tell jokes. Give everyone a chance to be the center of attention.

They can use an organized line to move from place to place.

Intellectual Development Milestones

Uses complete sentences, 1,540 word vocabulary, asks endless questions, learning to generalize, highly imaginative, dramatic, can draw recognizable simple objects.

Age appropriate activities to include in your gymnastics class:

Can understand four stations presented at once.

Play the Memory Game. Create a series of skills and see if they can remember what comes next.

They should be able to follow patterns easily. Try to teach them to stay at a station with a partner and keep working until it's time to rotate to another station. See if they know where to go next.

Give tasks involving counting or ask them to do four cartwheels.

Can perform three to four element sequences.

Age 5

Physical Development Milestones

Hops and skips, dresses without help, good balance and smoother muscle action, skates, rides wagon and scooter, prints simple letters, handedness established, ties shoes, girls' small muscle development about one year ahead of boys.

Age appropriate activities to include in your gymnastics class:

Balances on one foot on beam. Scale, lunge, knee scale, jumps across beam.

Jump rope, hoola hoop games.

Running and jumping with vaulting activities is more coordinated.

Basic tumbling and strength activities are appropriate. Bridges are introduced.

Include basic skills, gallop, skip, run and jump with a rhythm.

Emotional Development Milestones

Self-assured, stable, well-adjusted, home-centered, likes to associate with mother, capable of some self-criticism, enjoys responsibility, likes to follow the

Age appropriate activities to include in your gymnastics class:

Usually has no problem coming in to class and joining a group even if it's a new experience.

Likes to be watched, give them a turn to show off.

Can understand a correction. Only give one at a time.

Can understand safety rules and repeat them.

Social Development Milestones

Highly cooperative play, has special "friends," highly organized, enjoys simple table games requiring turns and observing rules, "school," feels pride and accomplishment, eager to carry out some responsibility.

Age appropriate activities to include in your gymnastics class:

Partner games – toss a pit cube back and forth.

Do a casting game on bars, one child holds a speed bump (or noodle) behind the other who is doing a front support. The casting child tries to kick the noodle with her legs as she casts. They trade places.

Do partner warm up games such as "Row Your Boat" or "Leap Frog."

Group relays work well. Keep it cooperative so everyone wins! They enjoy the "team" atmosphere of a class.

Intellectual Development Milestones

2,072 word vocabulary, tells long tales, carries out direction well, reads own name, counts to 10, asks meaning of words, knows colors, beginning to know difference between fact and fiction-lying, interested in environment, city, stores, etc.

Age appropriate activities to include in your gymnastics class:

Can understand four to five stations presented at once.

Create letters of their name with a jump rope. Do jump rope games.

Use pit cubes with numbers on each side to roll like a dice and see how many cartwheels they have to do.

Sit on a low beam and press up in a tuck and sing the ABC song, or spell your name, or count how old you are.

Can start to tell the difference if their legs are straight or bent in a cartwheel.

understanding development, you will be able to plan activities that are more appropriate for each age level. The more tasks that a child can complete, the better their selfesteem will become. Take time to understand child development. It will help you produce children that are happy, safe and willing to stay involved with gymnastics for years to come! The Gymnastic Department of SOKOL USA will conduct its Annual Meeting at this site on Saturday, August 1, 2009.

The Convention is the highest legislative body and judicial tribunal for the Sokol U.S.A., and shall consist of Supreme Lodge officers, delegates of the local lodges, representatives of the districts, Honorary officers, appointive officers, and guest delegates.

Each lodge in good standing is entitled to one (1) delegate for every fifty (50) members in good standing or major fraction thereof as of December 31 of the year preceding the Convention. Each lodge having less than fifty (50) members is entitled to one (1) delegate. The Supreme Lodge will reimburse the traveling and lodging expenses of not more than two delegates per lodge.

The lodge delegate shall be an adult member in good standing of the lodge for at least one year.

Lodges, districts, or individual members having motions or suggestions for the good of the Sokol U.S.A., or petitions, shall forward the same on forms furnished by the Supreme Secretary, not later than sixty (60) days prior to the Convention, to the Supreme Secretary, who shall deliver the same to the appropriate convention committee.

We encourage the membership and lodge officers to begin planning and selecting delegates as promptly as possible. In addition, we encourage submission of motions or appeals at the earliest possible time so that these topics can then be presented to lodges and delegates prior to their departure to the Convention. It is the intent of the Supreme Lodge to have certain Convention Committees meet prior to the opening of the Convention, which will require the attendance of at least one additional day.

The tentative schedule of Convention events will be published in the of the SOKOL TIMES as soon as it becomes available.


