From the President's View

The 33rd Convention of Sokol USA was convened in Pittsburgh at the Wyndham Hotel. It was striking to note at the opening of the Convention that we paid tribute to six former Supreme Lodge officers who have passed on since the last convention: Brothers Andrew Venglarchik, Jr., Stephen T. Tomko, John Bagel and Albert Walko, and Sisters Helen Stolzmann and Ann Halama - their contributions to Sokol too many to number, their absence significant.

As Convention Chairperson, I was pleased to introduce our MaryAnn Johanek, President of the First Catholic Sokol Ladies Association, and their Secretary, Irene Drotleff; Timothy Kuzma, President of the Polish Falcons; David Blazek, President of the National Slovak Society; Andrew Rajec, President of the First Catholic Slovak Union, and our own Matt Blistan Jr., Vice President of Greater Beneficial Union of Pittsburgh, all of whom extended greetings to the officers and delegates of Sokol USA on behalf of their organizations.

Our CPA, Al Eglow, addressed the convention stressing that fraternal are adequately protected. He stressed our need for new members and encouraged us to sell policies in the value of \$10,000. Allen Ferrone, our consulting actuary, discussed our surplus, solvency and assets, and also stressed our need to sell more and higher value policies. We have suffered a decrease in surplus for the first time in ten years due to the global economic downturn.

We sincerely thank all our guests who took time out of their busy schedules to address our delegates and to offer greetings. It is of great importance that fraternal societies work together to maintain a strong fraternal

base in our country. It is equally important that we publicize the work that we do in our communities and for our own membership. Which leads me to tell you all about the need to support the Scott Pracko family from Lodge 306. Scott and Amy accepted my invitation to speak about their son Matthew's condition called Alpha-1 Anti-Trypsin Deficiency, which could lead to liver disease. Scott and Amy are joining the Liver Life Walk in Montrose Harbor. 





New to the list of events at the America Sokol Slet was Co-ed Volleyball. Sokol USA was proudly represented by the Chicago Lodge 306 team.








Performing on balance beam is Farrell gymnast Roberta Pegg. Her strong performance earned her 2nd place in Level 3 Girls. Nice work Roberta!
