"Criteria to be used in judging are overall merits of applicants, cumulative grade average, community activities, college acceptance,


financial need and essay content," he continued.



2010 SOKOL USA NATIONAL BOWLING TOURNAMENT RULES

- 1. All participants must be bona-fide members of Sokol USA as of December 31, 2009.
- 2. Entrants will familiarize themselves with USBC Rule 319e. (Average Adjustment for Entry). Infractions mean disqualification.
- 3. A bowler who has qualified for a prize of \$600 or more in any event in a tournament within the previous 12-month period must report their actual score, position and amount won for possible re-rating under USBC Rule 319d.
- 4. Use 2008-2009 season's average of 21 games or more in USBC or USBC youth sanctioned leagues or if no 2008-2009 average, use a current USBC league average of 21 games or more by 2/15/2010. Ten pin or over rule is in effect for this tournament. Eligible bowlers with no average for current season may enter and bowl using 175 average for men and 140 average for women. As a moral sanction tournament, you do not have to be a USBC member, however, if you wish to be eligible for USBC awards you must become a member by paying the appropriate USBC associate member dues at the time of the event.
- 5. Participants may enter any or all events.
- 6. Entry fee is designated on entry form.
- 7. Failure to use correct average will disqualify score if submitted average is lower than correct average. Prize winnings shall be based on the submitted average if it is higher than the correct average. However, corrections in averages may be permitted up to the completion of the first game.
- 8. Ineligible participants will be responsible for disqualification of a team and its members in this tournament.
- 9. No bowler is to participate more than once in any event, except host lodge as necessitated by needs of other
- 10. All entries will be received in accordance with rules of the tournament.
- 11. No fees will be refunded.
- 12. The All-Events Prize Fund is optional. The fee is \$1.00.
- 13. Men bowlers will receive 100% of the difference between their average and 220 pins in each event. Maximum 3-game handicap is 168 pins per event. Women bowlers will receive 100% of the difference and their average and 190 pins in each entry. Maximum 3-game handicap is 177 pins per event.
- 14. All awards fees will be returned 100%. Handicap scores will be 60% of prize monies, while actual scores will comprise 40%. Prize ratio will be at least 1 in 8. Teams or bowlers will be awarded the highest prize for which they qualify in each event. Youth bowlers will be awarded trophies in lieu of cash per USBC Rule #100.
- 15. Deadline for entries is May 12, 2010. Singles and doubles will be bowled Saturday, May 15, 2010 at 9AM and 1PM. Team Event will be bowled Sunday, May 16, 2010 at 9AM. Bowling will be held at the Sokol Club.
- 16. All bowlers must present their 2009-2010 season USBC cards before the start of the tournament.
- 18. Teams will be made up of four men or four women. No mixed teams or doubles pairs.
- 19. USBC rules will govern for any situation not covered by the above rules.

From the Supreme Secretary...

Within this issue of the Sokol Times (Page 4), we have published the financial statement of the S.G.U. Sokol of the U.S.A. for the year 2009.

This certainly was a better year for SOKOL USA than 2008. We believe the financial storm is behind us, but there are still some choppy waters. Your Society regained its financial strength in a number of ways: (1) Increased surplus or retained earnings which now stands at about \$5.36 million. (2) Assets increased by almost \$500,000 dollars. (3) Net gains from operations, which means our expenses were less than our income, was \$82,000 dollars.

Our solvency ratio is 195 percent, which means we have \$195 dollars for every \$100 dollars of liability. This is a very sound financial footing that is the envy of many insurance companies and fraternal societies. Though this is a very strong indicator of Sokol USA's financial strength, we must continue to manage our assets and investments carefully.

If you have any questions concerning the financial information, please do not hesitate to contact the Supreme Secretary for further information or clarification.

On another note: Our key to maintaining our Society is to bring new people into this organization as insurance paying members, as well fraternally active participants. Our insurance products and premiums were revamped in order to meet the new standards mandated by the National Association of Insurance Commissioners. We have a new application form and we have new rate or premium tables.

Each Lodge was sent the new application forms and the latest premium tables. The application requires more information than our previous forms. If any lodge did not receive these forms, please contact Headquarters immediately. The *minimum amount of insurance is now \$3,000 dollars.* The premium charts now have gender rates, which means there are rates for males, and generally a lower rate for females. In the upcoming issues of the Sokol Times, we will publish the premium tables for the insurance products. We have the following types insurance products: Single Premium, Three Payment Life, 20 Payment Life, Life to Age 85, and also a Juvenile Term to Age 18.

The premiums per thousand dollar of insurance are lower than our previous rates. The premium rates are quite competitive, and not just for juveniles. Recently, I compared a solicitation for insurance which I had personally received in the mail. Our Sokol USA rates are very good and, as I said before, quite competitive as compared to the solicitation. If you are seeking insurance for "final needs," call Headquarter or ask your lodge officer for information.



Monday, August 3, 2009



Recommendation #1:

In accordance with the New Motions Committee recommendation No. 1, we move that a new Section 18 be added to Article V of the By-Laws (The Supreme Lodge), as follows:

"The immediate Past President of the Slovak Gymnastic Union Sokol U.S.A. shall be invited to attend meetings of the Supreme Lodge with right to speak but no voting privilege." (Reference page 14 of your current By-Laws for the location of this new Section.)

Recommendation #2:

In accordance with the New Motions Committee recommendations No. 2 and No. 3, we move that a new Section 11 be added to Article XVI as follows:

"Effective January 1, 2010, the Sokol USA will issue insurance certificates in \$ 3,000 minimum and \$50,000 maximum coverage. The age limit for new members is to be 80. However, the

Recommendation #3:

Finally, Article XXII, Section 1, p. 75, (Membership) shall be amended to read "80" instead of "70."

Sis. Walko thanked and dismissed the By-Laws Committee.


Mr. Eglow thanked the delegation for their hard work and participation during the Convention. He encouraged us to implement all of the new ideas that arose during the Convention.
