During the holidays I received many cards and good wishes. One of the cards which arrived was a bit mysterious. It came from Europe and I did not recognize the last name and return address.


When I opened the card, it was from a very old friend who had just remarried. The card read new name, new address, the same person.





American Sokol Extends Invitations

In October, Director of Men Todd Yatchyshyn and I attended the America Sokol Board of Instructors Meeting in Detroit. This was a comprehensive threeday meeting that reviewed all aspects of their extensive physical fitness program, including a review of the Texas Slet, Instructors' School, National the organization's Strategic Plan, and much more. It was a very informative meeting that only reinforced my belief that it would be most beneficial for Sokol USA to work more closely with American Sokol, especially by taking part in activities where invitations have been extended.

Presently, there are several activities that Sokol USA lodges might be interested in taking part. They are the American Sokol Winter Slet, the Youth Program, and the Skills Program. In the spring, American Sokol will again sponsor a Fitness Test and this summer they will host the National Camp and Instructors' School. Sokol USA has been invited to participate in all these programs, so please consider joining the ones that could supplement your present activities or offer an exciting opportunity to a young person in your lodge.

Details about the American Sokol Winter Slet and the Youth Program appeared in the December issues of the Sokol Times, or you can go to the American Sokol website at www.american-sokol.org.

Over the years, Sokol USA children have asked about the passports and opportunities offered through the ASO Youth Program, such as the Pen Pal program. For \$5.00 per child, they can take part in these activities and they are also encouraged to visit the Sokol Kids website. More information about the Youth Program can be obtained by contacting Bob Kucera via e-mail daffybob@comcast.net.

The skills program is also detailed on the American Sokol website. Click on the BOI website in the top right-hand corner of the homepage. Achievement ribbons are also available, for purchase by

contacting the BOI Secretary Juanita Logiudice via e-mail at <u>juanita@american-sokol.org</u> or calling the office at 708-255-5397.


The American Sokol BOI consists of their six-member national staff and the Directors of Men and Women from each of their six districts. Within the districts, there are over 30 active units. They meet annually, but also conduct monthly conference calls. In addition to providing written reports highlighting district activities, many other committee reports were prepared for the annual meeting on topics such as Tournament Rules, Youth Membership, the New Wing Program and Uniforms. Most reports were available on their website prior to the meeting, enabling participants to read them in advance and bring a printed copy to the meeting for further discussion.

Another interesting agenda item, Probortunity Suggestions, covered areas of concern like fundraising and activities for specific age groups – looking at them not as a "problem" but instead as an "opportunity." Discussions covered topics such as holding a family or adult camp, a golf or dodge ball tournament, an "a-thon" activity such as cartwheel, headstand or volleyball, and a "dancing" activity, which could possibly be modeled after "Dancing with the Stars."

Uniforms are certainly an area of interest to Sokol USA since we obtain them from American Sokol, so it is important to know that at the BOI meeting the following recommendation was passed:

A new more appropriate and general purpose American Sokol uniform will replace the existing uniforms for all classes. The design will be consistent across all required and optional items. Colors of the background and design will change between the 4 age levels (Tots, Children, Juniors, Seniors).

Required – Each American Sokol participant is required to purchase these uniform parts. Possible uses include but are not limited to Calisthenics, parades, meetings, gatherings, PR

performances, etc...

- Tots: T-shirt and shorts - Children (Boys and Girls): T-
- shirt and shorts
 Juniors: T-shirt and shorts
- Seniors: (There would be no special uniform for the Senior COED II group) Polo shirt and shorts or pants

Samples of possible shirts and shorts were available at the meeting. All were tasteful and should meet with the approval of most everyone. Before the new uniforms are finalized, Sokol USA and other sister organizations will be taken into consideration, especially concerning a Sokol logo. For this year, the present uniforms will remain in effect. The Uniform Division will not order any additional inventory, but they will continue to sell the existing uniforms on hand. The new uniforms will not be available for ordering until August 2010. The intent is to have the formal, national introduction at the 2011 Sokol USA Slet.

Reasons for the uniform changes include difficulty in obtaining a uniform supplier for

the present style uniforms and the expense of maintaining an inventory of new uniforms. According to the proposal, ordering will be done by individuals or units directly from the supplier. The new uniform styles were chosen with the intent to demonstrate and exhibit a professional nature, which will help market American's Sokol's strength as а national organization.

Other efforts to market the organization are underway through the Strategic Plan, which public aims to increase awareness of Sokol and grow membership. Many elements of the American Sokol Strategic Plan are similar to what we had hoped to do for Sokol USA through Project Second Century. To learn more about the Strategic Plan, there is a link on the home page of the American Sokol web site. There you will find a wealth of information on all four of the core programs physical, educational, cultural and social. Also there are helpful resources Instructor on Standards and Volunteer Management.

Standardizing at least a portion of the activities within all units is another way American Sokol is hoping to market the Sokol program. The Sokol Fitness Program described in the Strategic Plan is a general fitness program for people of all ages to improve their health, fitness level, and overall well being. Details on how to implement the program are

provided and all units are urged to incorporate this core program into their existing programs.

On an individual unit basis. other additions or changes are also under consideration, such as increasing programming to run throughout the day and evening under the direction of a program manager. In at least one unit, short-term programs are being planned that will be offered at one fee for members and another fee for non-members. Through this they hope to reach out to the local community by exposing them to Sokol programs before they actually become members.

This is just a brief overview of the information that was covered at the 2009 BOI meeting. Todd and I were overwhelmed by the many committees and programs but extremely impressed with the oversight provided by the national leadership and the dedication of everyone involved. It was encouraging to see their efforts to keep the Sokol ideals alive and their focus increasing membership. encourage you to visit the American Sokol website and consider participating in one or more of the programs offered to Sokol USA by our sister organization.







Sokol Display at University Slovak Festival




MCT District President Matt Blistan shows the display to a student from Slovakia.







- The Convention of the Sokol USA is the highest legislative body and judicial tribunal for the entire Sokol USA, for all its components, and all its membership.
- The Convention will be open for registration on Saturday, August 1, 2009 from 10:00 AM to 5:00PM and on Sunday, August 2, from 10:00 to 12:00 PM.
- Committee's will meet on Saturday, August 1, 2009. Advisors will notify Committee members of time and place.
- The first session will convene on Sunday, August 2, 2009 at 1:00PM. It is anticipated that all committee reports will be prepared.
- Further sessions will be held Monday through Tuesday, August 4, 2009. Morning sessions from 9:00 AM and afternoon sessions from 1:30 PM.
- All convention sessions shall be called to order on time.
- Badges will be provided for delegates, alternates, district representatives, Supreme Lodge Officers, Legal Advisor, and Guest Delegates. All the foregoing shall be required to wear their identification badges at all Convention sessions.
- Delegates and District representative shall sit in the section reserved for them and shall be in their seats before the opening of each session.
- Alternates and guests shall sit in the section reserved for them.
- 10. Guests will be introduced at the end of each session. Messages will be read at the morning sessions.
- The Convention Hostess shall deliver all communications. He/She shall escort all guest speakers to the podium.
- 12. The Convention Sergeant-At-Arms shall see to it that the sessions are not disturbed by anyone. S/he shall sign in all guests. S/he shall announce all guest speakers and permit them to enter upon consent of the convention Chairperson.
- 13. Two permanent microphones will be set up.
- 14. The Convention Secretaries selected by the Supreme Lodge will take minutes. The minutes of the preceding sessions will be read each morning immediately after the roll call. Copies of the minutes will be prepared for each delegate. Minutes will be published in the Sokol Times within 90 days after the Convention.
- 15. One set of tape recording of the Convention proceedings is made.
- 16. Robert's Rules of Order are to be used as per article XXVII. Section 7 of the By-Laws.
- 17. The formal opening of the XXXIII Sokol USA Convention will be 1:00 PM on Sunday, August 2, 2009 with our customary opening ceremonies, welcoming address, roll call and introductions.
- 18. The Verification Committee will give its report to the convention as to who are bona-fide delegates, alternates, district representatives, Supreme Lodge officers, and guest delegates, and the Committee's determination of the number of votes accorded to each delegate.
- 19. The Committee on the order and Program of the Convention will give its report for acceptance.
- 20. There will now be the election of the Chairperson and Vice-Chairperson of the Convention.

- 21. All Convention committees are to meet Saturday, August 1, 2009 to complete their deliberations and be prepared for their presentation on Sunday, August 2, 2009. They shall be ready to report to the Convention or until they are formally dissolved by the Convention Committee.
- 22. All recommendations will be given in writing to the proper Convention Committee.
- 23. The Committee on Elections and Ballots shall have supervision of the arrangements for the distribution and casting of ballots and their preservation until placed in the hands of the Supreme Secretary, who shall seal and file them.
- 24. Changes in the structure of the Supreme Lodge, district, or subordinate lodge, or in the duties or responsibilities of any officer, committee, or department must be recommended by the New Motions Committee. Only then, after being passed by the Convention, may a vote be taken in order to request the By-Law Committee to recommend the necessary By-Law changes.
- 25. All proposed changes to the By-Laws must be submitted to the Convention By-Laws Committee before these changes are presented to the convention for consideration.
- 26. The By-Law Committee will come forward and state "In accordance with the New Motions Committee recommendation No._______, w move that Article________, section_______, of the By-Laws be changed to read from _______ to ______ for the following reason________."
- 27. All Motions, resolutions and recommendations shall be written, signed by the mover and presented to the Convention Secretary.
- 28. When a Committee is initially called to report, the Advisor introduces the Committee Chairperson who then introduces the other members of the Committee. The Committee Secretary reads a proposal. A majority Committee member moves for either adoption or rejection, and explains the majority rational. If there is a minority position, a minority Committee Member moves to amend, reject or adopt, and explain the minority rational. The majority Committee member may accept the amendment or withdraw the original motion. After a reasonable time for discussion, the Convention Chairperson states the question and opens the floor for discussion, the Convention Chairperson asks "Are you ready for the question." Upon a delegate answering "Question." the Convention Vice-Chairperson again states the question and calls for a vote.
- 29. The Convention Vice Chairperson or designated member will record the names of those ask to be recognized for debate, or to amend or second motion.
- 30. Delegates shall be entitled to the floor only if they rise, come to the micro-phone, address the Chair, give their name and that of the lodge or district they represent.
- 31. A delegate may speak not more than twice or longer than five minutes each time on any one question on the same day.
- 32. No delegate may speak a second time to the same question if one who has not spoken requests the floor.
- 33. The Convention, by a two third vote may limit equally the time and the number of speakers for each side of a question and the total time for the debate on a particular question.

34. The Convention Vice Chairperson or designated member will signal when the allotted time has expired.

CONVENTION COMMITTEE MEETINGS

- 1. A Committee shall meet as necessary during the Convention, or until it shall dismissed upon completion of its duties by the Convention Chairperson.
- 2. The advisor shall call, chair, and open the first meeting of the Convention Committee. The first item of business will be the election of the Committee Chairperson and Secretary.
- The Convention Committee will be supplied with a packet containing a synopsis of items to be considered, the synopsis will be based upon recommendations, petitions and grievances, or appeals received in Headquarters.
- 4. It will be the Chairperson's responsibility to determine which recommendations should be made to the Convention using Minutes of the XXXII Convention as a guide if no items are provided.

Bro. Stephen Barron, Lodge 93, moved that the Convention Operations and Procedures be adopted. Bro. Matt Blistan seconded the motion. MOTION CARRIED.



Sis. Shurina read the recommendations of the Committee for Convention Expenses, all of which were unanimously decided.

- The committee recommends that the Convention Chairman and Vice Chairman receive \$50.00 per diem. There shall be no "double dipping" of per diems. If the Chair or Vice Chair receives 2 or more per diems due to other offices or positions he or she would be allowed to take the higher amount.

- 5. The Committee recommends that the Supreme Lodge reimburse the travel expenses of not more than two delegates per lodge as per Article IV, Section 2 of the By-Laws.
- 6. The Committee recommends that the lodging expenses be paid for the Delegates, Officers and District representatives.
- 7. The Committee recommends that the following meals be provided to the Delegates, Guest Delegates, Convention Chairpersons, Legal Advisor, Supreme Lodge Officers, Honorary Officers, Editor, Convention Hostesses, Sergeant at Arms, and officially invited guests:

The Gymnastic Department shall nominate the candidates for the Office of Director of Men and Director of Women, and shall recommend to the convention that the nominees be elected by the convention to their respective offices.

- 3) All member delegates seeking office shall be properly nominated; seconded; duly elected by secret ballot by the officers and delegates present at the convention; as provided by the By-Laws of the Slovak Gymnastic Union Sokol.
- 4) Each delegate shall be eligible to run for one office only.
- 5) As soon as the nominations are completed, the Committee will prepare ballots on which names of candidates for each office shall appear in alphabetical order and shall show the number to be elected.
- 6) A delegate nominated for office who has been appointed previously to the Committee shall be replaced by a non-candidate delegate Supreme Lodge Officer.
- 7) The Committee on Ballots shall have complete charge of the election; and after voting is completed shall count and preserve the ballots and promptly after tabulation announce the results to the Convention.
- 8) Every candidate shall have the right to be present during the tallying of the ballots, or shall have the right to have a delegate present to represent him or her.
- 9) Only one ballot shall be taken at the election. When more than one (1) officer is to be elected for the same office, votes must be cast for the total number to be elected, otherwise the ballot shall be deemed void. All candidates to be elected must receive a simple majority of the votes of the Convention.
- 10) In the event of a tie for any office, another ballot shall be taken only for those affected by the tie vote and the candidate receiving the highest number of votes on the run off shall be elected.
- 11) Any person nominated for more than one office will be listed for only the one nomination which he or she accepted.
- 12) The nominator must submit in writing to the Secretary of the Ballot Committee the name of the nominees as soon as he or she makes the nomination.
- 13) Any lodge with less than 10 votes may have up to three (3) ballots; lodges with 11 or more votes may have up to five (5) ballots. The sum of these votes will equal the allotted votes as presented by the By-Laws. Ballots will be color coded in case delegates would like to split their votes.
- 14) Each lodge shall have one (1) vote for every twenty-five members or fraction there of for his or her lodge, according to the statement of membership for the last month preceding the convention.
- 15) Delegates representing lodges which have fewer than twenty-five members, Supreme Lodge Officers, Guest Delegates and District Delegate shall have one (1) vote each.
- 16) The election shall take place no sooner than the next day or two sessions after the nominations are completed.
- 17) No write-in votes shall be accepted.
- 18) Article V, Section 1, of the By-Laws provides for the election of the following officers: President, Vice President, Financial Secretary, Treasurer, Seven Members of the Finance Committee, Chairperson of the Cultural Activities, Director of Men and Director of Women.
- 19) The Ballot Committee shall have the right to set aside all questionable tallies and only count correct votes and consider questionable ones after all others are tallied. Delegates not answering to the first call have to wait for the second call before voting, and if the second call is not answered the delegates shall lose his right to vote. As soon as the Committee closes the election no further ballots will be accepted. In the

event of a dispute as to number of votes that a lodge is entitled to, the amount of votes certified by the Verification Committee shall be binding.

Sis. Check moved for adoption of the Committee's report. There was no discussion. MOTION CARRIED.

Mr. Timothy Kuzma, Polish Falcons, stated that they allow non-members to join activities once (sometimes at a slightly higher participation fee) so they can experience the benefits of membership. They are currently organizing an Inter-Polish bowling tournament, to which all other Polish organizations will be invited. This summer, they sent 10 children to Poland for 2 weeks. They equipped each child with a travel journal and a memory disk (to be used in digital cameras) with the stipulation that the memory disks be returned to the Polish Falcons. The pictures will be posted on their website. He suggests trying new ideas – even if the event doesn't result in an increase in immediate membership – it increases awareness in the community. They're having a youth festival in Washington DC next year.

Ms. MaryAnn Johanek FCSLA explained how they organize Join Hands Day activities, Red Cross Blood Drives, Clean the Highway, Adopt-a-Family (through the Salvation Army), volunteering at the Joseph House (to support homeless), the Light of Heart and holding a Flea Market. They also recently helped to start a Slovak school. She's found that kids love to work and get involved if you feed them! She encouraged us to let kids help with the planning to get them excited and involved in the work. The internet has been a great tool for them. They have a rudimentary calculator to help potential customers see how much a life insurance will cost depending on their age, etc. The home office helps subsidize activities and has a matching funds program, up to \$500.

Mr. David Blazek, NSS, explained that they also invite people to join their activities once at no additional cost. They have annual art and poetry contests for children. There is a Christmas ornament contest for children and adults; the ornaments are donated to a nursing home. At their conventions, they subsidize non-members to attend and have a youth convention running simultaneously. They recently opened a Slovak Museum at their Headquarters and extended an open invitation to visit the site.

Bro. Matt Blistan, GBU, noted that this brain-storming and idea sharing is what occurs at National Fraternal Congress of America. One idea is to have a blood drive on the same day all

throughout the nation. A blood drive would be great for generating positive Public Relations for all fraternals. Two years ago, they supported troops with Operation Reach Out. They collect items to send to troops in Iraq and Afghanistan. So far, they've sent out over 1,000 boxes.

Sis. Yatchyshyn thanked the guests for speaking and encouraged the delegation to check out the website of the other fraternals.

Sis. Walko thanked Sis. Yatchyshyn and the guests for the report and their suggestions. She reminded the delegation that some Sokol USA members have served, or are currently serving in the military.

Sis. Walko adjourned for the day with the next session to commence tomorrow morning at 9:00 AM.
